

FOREIGN PRIVATE INVESTMENT IN NIGERIA - 1999

- STATISTICAL SURVEYS OFFICE

ABSTRACT

The net flow of foreign investment into the Nigerian economy fell sharply to N1,779.1 million in 1999 from N24,0788.9 million in 1998. The breakdown of the net flow positions revealed that different components dropped in the review period. The survey showed that the cumulative level of foreign direct investment in the country was N155,761.7 million, mainly through the shares of mining and quarrying as well as manufacturing and processing sub-sector. The debt profile of foreign investors in 1999 showed a rise in the long-term liabilities by 0.25 per cent, while out payments under current liabilities also increased during the review period. The review further showed that, the cumulative reserves for depreciating of fixed assets rose from N88,699.4 million in 1998 to N96,402.9 million in 1999. The share of cumulative paid-up capital in foreign-owned companies increased slightly during the review period, while foreign share capital decreased from 30.5 per cent in 1998 to 30.4.

INTRODUCTION

The results of the annual foreign private investment survey conducted by the Central Bank of Nigeria in 1999 are presented in this report. The survey covers 298 establishments that are either fully foreign owned or are in partnership with Nigerians/Nigerian Agencies or enterprises doing business in Nigeria. Questionnaires were retrieved from 190 companies representing a response rate of 63.9 per cent. Statistical adjustments were however made for institutions that did not respond. The analysis of the survey returns are presented in eight parts. In Part I, the flows of foreign investment by regions of origin, components and sectoral distributions are discussed. The cumulative and net foreign investment are analysed in Part II and Part III, respectively. Part IV focuses on foreign investment in the manufacturing and processing sub-sector by industries

and by regions.

The cost and book values of the fixed assets of the establishments are examined in Part V, while the cumulative and current reserves for depreciation of these assets are presented in Part VI. The ownership structure and equity of the companies are presented in Part VII, while Part VIII contains the summary of the report.

I. FLOW OF FOREIGN INVESTMENT

The overall net flows of foreign private investment in Nigeria fell sharply to N1,779.1 million in 1999 from N24,078.9 million in 1998. Net investment flows into Nigeria from all the regions declined in the review period. The companies of United Kingdom origin recorded net inflow of N1,235.6 million or 69.5 percent of total inflow in 1999 compared with N14,146.4 million registered in the preceding year.

The net investment inflow to companies, of Western Europe, (excluding the UK) origin declined to N1,261.0 million from N2,147.1 million in 1998. "Other unspecified countries" reported a net inflow of, N710.7 million, compared with N8,279.1 million in 1998. While the companies of U.S origin recorded a net outflow of N1,489.4 million during the review period. (Table 1)

Components of Net Flow

A breakdown of the net flow positions revealed that different components dropped in the review period. The contributions of unremitted profit fell from N9,540.0 million in 1998 to N2,719.7 million in 1999. The low volume of investment through this component is traceable largely to U.K. region, which accounted for 42.6 per cent of the total.

The net capital flow through changes in foreign share capital also declined to N377.8 million from N4,385.3 million in 1998. The companies of “other unspecified countries” origin accounted for 90 percent of inflow through this investment component. Other components of net capital flow namely trade and supplies’ credit; other foreign liabilities and liabilities to head office recorded net outflows during the review period. The trade and suppliers’ credit, which represents indebtedness to overseas suppliers by enterprises operating in the country, recorded a net outflow of N76.2 million in 1999. Liabilities to head office of foreign enterprises showed a net outflow of N1,122.5 million, while other foreign liabilities also recorded a net outflow of N119.7 million during the review period (Table 2).

Annual Flow of Foreign Private Capital

The annual flow of foreign private capital is analyzed further into seven economic sectors according to the components of the net flow and regions of origin of the investment. The economic sectors are mining and quarrying, manufacturing and processing, agriculture, forestry and fishing, and transport and communications. Others are building and construction, trading and business services as well as miscellaneous.

All the seven economic sectors except mining and quarrying reported net capital inflow during the review period. The manufacturing and processing sector registered a net inflow of N1,778.3 million, representing 99.95 per cent of the total inflow (Table 3). Companies of UK origin through re-investment of unremitted profit contributed largely to the sector’s inflow. Trading and business services recorded the second largest net inflow of foreign private capital in 1999. At N466.8 million, the bulk of the inflow was financed by companies of Western Europe (excluding the UK) region through unremitted profit. The miscellaneous

economic activity sector registered net inflow of N410.9 million largely financed by companies of other unspecified region. Companies of U.S. origin, which dominated the transport and communications sector registered net inflow of N130.7 million in 1999.

The building and construction sector registered net inflow of N107.5 million largely financed by companies of Western Europe (excluding the UK) mainly through unremitted profit and other foreign liabilities.

The net outflow of N1,115.1 million recorded in the mining and quarrying sector resulted from out payments made by companies of U.S. origin to reduce debt obligations under other foreign liabilities.

II. CUMULATIVE FOREIGN INVESTMENT

Cumulative foreign private investment in the country is analyzed under two classifications as follows:

- (i) paid-up capital plus reserves (comprising of unremitted profits and changes in foreign share capital).
- (ii) other liabilities (comprising of trade and suppliers' credit, other foreign liabilities and liabilities to head offices).

Regional Aggregates

In 1999, cumulative foreign private investment in Nigeria was N154,188.6 million representing an increase of 1.2 per cent over the level in the preceding year (Table 4). All regions except the US contributed to the increase. Both the paid-up capital plus reserves and other liabilities also increased. While the aggregate paid up capital plus reserves rose to N73,554.7 million from N70,457.2 million in 1998, other liabilities fell

from N81,952.4 million in the preceding year to N80,633.9 million. The companies of Western Europe (excluding the UK) accounted for 43.6 and 63.8 per cent of the aggregate paid-up capital plus reserves and other liabilities respectively in 1999. The paid-up capital plus reserves and other liabilities of establishments of the U.K. origin were N17,954.3 and N14,649.2 million, representing 21.4 and 18.2 per cent of the total in each category. The companies of Western Europe origin led the other regions, in spite of its share of cumulative foreign private investment declining to 54.8 per cent from 64.1 per cent in 1998. The share of investment by companies from the U.K. increased to 21.1 per cent from 20.6 per cent in the preceding year. The share of those from the U.S. fell from 14.2 per cent in 1998 to 13.0 per cent while the relative share of those from Asia remained at 2.3 per cent. The relative share of other unspecified countries rose slightly to 9.3 per cent from 9.0 per cent in 1998 (Table 4)

Sectoral Aggregate

The analyses of the cumulative foreign private investment in 1999 are disaggregated into sectors in this section. The cumulative levels for 1999 was obtained through addition of the net positions for the review period for each of the major groupings paid-up capital plus reserves and other liabilities to the stock level of 1998. The cumulative foreign investment in the manufacturing and processing; trading and business services increased to 23.3 and 7.0 per cent from 22.6 and 6.9 per cent, respectively in 1998. The shares of mining and quarrying sector and miscellaneous sector fell to 38.8 and 27.0 per cent from 39.3 and 27.4 per cent in 1998 respectively, while the shares of other sectors remained at the preceding year's level (Table 5).

Maturity Pattern of Other Liabilities

Total liabilities to overseas concerns by foreign companies operating in Nigeria as at end of 1999 was N82,206.4 million, representing an increase of 0.31 per cent over the level a year earlier (Table 6). The liabilities are disaggregated into current and long-term liabilities. Indebtedness up to one year resulting from trade and suppliers credit are regarded as short-term or current liability while those exceeding one year comprising of other liabilities and liabilities to head offices are long term. The increase in the level of cumulative liabilities was attributed mainly to the net inflows recorded through long-term liabilities which rose by 0.26 per cent to N124,857.4 million in 1999. While the liabilities to the companies of U.K. and Western Europe origins increased by 0.07 and 0.84 per cent above the 1998 level, and liabilities to companies of Asia declined by 6.20 per cent to N1,803.9 million. On sectoral basis, the total cumulative liabilities of building and construction and trading and business services sector increased by 0.83 and 0.41 per cent through firms of Western Europe and the U.K. respectively in the review period. However, total cumulative liabilities of mining and quarrying sector and miscellaneous activities declined during the period.

III. NET INVESTMENT

Sectoral and Regional Distribution

This section examines the contributions of the regions and the various economic sectors to the net flow positions, based on paid-up capital plus reserves and other liabilities. Paid-up capital plus reserves comprise unremitted profits and changes in foreign share capital while other liabilities are made up of trade and suppliers credit as well as other foreign liabilities and liabilities to head office. The net inflow of N1,779.3 million

of foreign investment into the country in 1999 resulted from inflow of N3,097.8 million through paid-up capital plus reserves and outflow of N1,318.5 million through other liabilities. Net inflow of foreign investment from all the regions declined except the U.S., which recorded a net outflow of N1,489.4 million during the period. Investment inflow from companies of U.K. and Western Europe origins fell from N14,078.2 million and N2,215.3 million in 1998 to N1235.7 and N1,261.0 million, respectively in the review period. Net inflow of foreign investment from Asia and other unspecified regions also declined to N61.2 and N710.8 million from N383.6 and N8,270.1 million in 1998. Net inflow to the manufacturing and processing sector fell by 44.5 per cent to N1,778.3 million from N3,206.7 million in 1998. The net investment flows to building and construction; trading and business services and miscellaneous also declined to N107.6, N466.9 and N411.1 million from N2,628.5, N6,834.7 and N10,643.2 million in the preceding year. However, there was significant rise in the transport and communications sector's net inflow which rose from N16.6 million in 1998 to N130.7 million in the review period.

The mining and quarrying sector recorded a net outflow of N1,115.3 million in 1999, compared with a net inflow of N749.1 million in the preceding year (Table 7).

IV. FOREIGN INVESTMENT IN THE MANUFACTURING AND PROCESSING SECTOR

Based on the international standard of industrial classification (ISIC) 28 industrial groups are analysed under the manufacturing and processing sector (Table 9). Using two broad investment component paid-up capital plus reserves and other liabilities to analyse the sector, the level of cumulative foreign investment increased by 67 percent from N34,587.6 million in 1998, indicating a net investment of N2,309.4 million. The rise

was accounted for by increase in the levels of both paid-up capital plus reserves and other liabilities. The proportion of paid-up capital plus reserves and other liabilities in total investment in the sector remained as in the preceding year. The increase in aggregate investment in this sector was accounted for by 13 of the industrial groupings. Cumulative investment levels in nine groups remained static, while it fell in four groups. As in the preceding years, the non-ferrous metals group experienced divestments of N232.1 million in the review period. Petroleum refineries sub-group remained the preferred sub-sector by foreign investors in the manufacturing and processing sector in Nigeria. The sub-group reported cumulative investment of N9,467.8 million, representing 25.7 per cent of the aggregate cumulative foreign investment in the manufacturing and processing sector. The petroleum refineries sub-group was followed by food products sub-group with investment of N6,941.1 million or 18.8 percent of total, while other chemicals group attracted investment of N5,201.2 million or 14.1 per cent during the review period.

Net Investment in the Manufacturing and Processing Sector.

An analysis of net investment in the various industrial groups within the manufacturing and processing sector is presented in Table 10, while the regional breakdown of the data is contained in Tables 11-15.

The net flow of investment into the manufacturing and processing sector fell by 41.7 per cent to N2,309.3 million from N3,958.0. million in 1998. Of the total net investments in the sector, beverages, transport equipment and textiles sub-groups accounted for 46.2, 26.7 and 12.9 per cent, respectively (Table 10). The results of the survey showed that new investment from companies of U.K. origin in the manufacturing and processing sector rose to N1,459.6 million from a net inflow of N24,6 million in 1998. The increase resulted from substantial rise in paid-up

capital plus reserves especially by companies in the beverages industry, which accounted for 71.6 per cent of new investment in the region during the period (Table 11). The companies of U.S. origin operating in the paper industry recorded a net outflow of N152.2 million in 1999, compared with N335.1 million net inflow registered in the region in 1998. Both the paid-up capital plus reserves and other liabilities contributed to the capital outflow during the period (Table 12). The level of investment of companies of Western Europe origin (excluding the U.K) in the manufacturing and processing sector increased substantially from N167.3 million in 1998 to N910.2 million. Foreign investment flow by companies from Asia region fell drastically to N79.3 million from N523.0 million in 1998. The paid-up capital plus reserves recorded a net inflow, while other liabilities registered net outflow in the review period. The decline was attributable to net outflows in rubber and plastics products, non-ferrous metals and electrical machinery, which together added up to N265.9 million, while net inflow through the textile industry amounted to N298.4 million (Table 14).

At N12.5 million or 0.54 per cent of the total net inflows for the manufacturing and processing sector, companies of other unspecified countries recorded the least injection of foreign capital into the economy in 1999. Out of the five sub-sectors that registered capital flows through the region, metal products (fabricated) accounted for N10.5 million or 84.0 per cent of total net inflow into the region.

However, non-ferrous metals industry recorded net outflow of N4.8 million (Table 15).

V. FIXED ASSETS

Fixed Assets (At Cost).

The net flow of investments in fixed assets (at cost) are presented in Table 16, while Table 17 shows the values of the total stock of fixed assets (at cost). The analysis in Table 17 is further disaggregated into regions in table 18-22. The fixed assets considered are real estate (land and building), machinery and equipment, motor vehicles and other (unspecified) assets.

(a) Net Investment In Fixed Assets At Cost

The result of the survey revealed that aggregate net fixed assets worth N5,321.5 million were added to the existing stock by foreign owned companies in Nigeria in 1999. However, fixed assets worth N543.0 million were retired during the year, leaving a net accretion to stock of N4,778.5 million. This contrasts with N120,000 million new fixed assets acquired in 1998 and N11,000 million fixed investment written off in the same period. A further analysis of the net flow of fixed assets investments revealed that 41.2 per cent and 24.2 per cent of aggregate accretion to the stock of fixed assets were made by the mining and quarrying sectors, respectively. Analyzed by components of fixed assets, machinery and equipments, real estate and other assets had net accretions to stock of fixed assets of N1,493.1, N577.9, N1,860.8 million, which represented 31.2, 12.1, and 38.9 per cent of aggregate net accretion, respectively. Companies ;of Western Europe (excluding the U.K) were largely responsible for the development. They had accretion of N631.3, N190.3 and N1,580.1 million to stock of machinery and equipment, real estate and other assets, respectively.

(b) **Total Stock of Fixed Assets (At Cost)**

The data on the stock for fixed assets (at cost) for all the sectors and regions are derived by adding the value of assets acquired less assets at cost for 1998 (Table 17). The value of the total stock of fixed assets rose from N293,189.5 million in 1998 to N297,708.8 million, representing an increase of 1.5 per cent above the 1998 level. All the asset components contributed to the increase, except motor vehicles which declined by 1.5 per cent. Real estate, furniture and fixtures and other assets recorded increases of 3.1, 3.9, 1.8 per cent respectively above the preceding year's level. On sectoral basis, the mining and quarrying sector accounted for the largest share of total fixed assets at cost, as its value of total stock of fixed assets stood at N162,519.9 million or 54.6 per cent of the total. This was followed by the manufacturing and processing sector with 23.8 per cent, while miscellaneous economic activities was 8.7 per cent, transport and communications 4.8 per cent and trading and business service, 4.1 per cent. (Table 17).

(c) **Value of Fixed Assets At Cost By Companies of U.K. Origin**

Valued at N52,487.1 million, the stock of fixed assets at cost of companies of U.K origin operating in the economy in 1999, represented 17.6 per cent of all the fixed assets of foreign owned companies, as against the previous year's share of 17.5 per cent. The manufacturing and processing sector accounted for 83.7 per cent of the total stock value of fixed assets belonging to companies of British origin in the review period. Other sectors with improved assets holdings were trading and business services and miscellaneous with N4,086.1 and N2,726.3 million, respectively. However, mining and quarrying, agriculture, forestry and fisheries,

transport and communications, building and construction sectors remained stagnant (Table 18).

(d) **Value of Fixed Assets At Cost By Companies of U.S.A. Origin**

At N88,572.8 million, the value of fixed assets at cost of companies of U.S, origin accounted for 30 per cent total fixed assets of foreign companies in the review period. This indicated a relative share of 29.8 per cent for the region with respect to aggregate value of fixed assets, compared with 30.1 per cent in 1998. As in the preceding year, the mining and quarrying sector led other sectors in value of fixed assets with N54,268.4 million, representing 61.3 per cent of total value of the fixed assets of companies of U.S. origin. The miscellaneous economic activity which followed recorded N16,314.0 million or 18.4 per cent of the total. However, the value of fixed assets at cost in agriculture, forestry and fisheries, building and construction, and trading and business services sectors remained at the 1998 levels (Table 19).

(e) **Value of Fixed Assets At Cost by Companies of Western Europe Origin (Excluding the U.K.)**

The total value of fixed assets at cost of companies of Western Europe (apart from those of UK origin) rose from N136,730.6 million in 1998 to N139,146.0 million in the review period. This indicated the share of the region increased to 46.7 per cent from 46.6 per cent of the aggregate value of fixed assets at cost for all the regions recorded in 1998. The mining and quarrying sector registered the highest value of fixed assets worth N107,626.2 million or 77.3 per cent of the total assets acquired by companies in this region. Transport and communications sector followed with N13,623.4 million or 9.8 per cent.

All the other sectors recorded increases in 1999, except trading and business services, which declined by 13.3 per cent below the level in 1998 (Table 20).

(f) **Value of Fixed Assets (At Cost) by Companies of Asian Origin**

In the review period, the total value of fixed assets at cost of companies of Asian origin stood at N4,712.3 million, representing an increase of 7.9 per cent above the level in 1998. The manufacturing and processing sector accounted for the largest share of total fixed assets at cost in the region, representing 59.1 per cent of the total stock. All the other sectors remained at the previous year's level (Table 21).

(g) **Value of Fixed Assets (At Cost) Companies from "Other" Unspecified Countries/Region**

In 1999, the total value of fixed assets (at cost) of N12,790.7 million reported by companies of other unspecified regions, indicated an increase of 2.6 per cent over the previous year's level. At N6,243.1 million, the manufacturing and processing sector accounted for 48.8 per cent of total assets acquired in the review period. The building and construction and trading and business services sectors also recorded marginal increases. However, investment in fixed assets at cost in mining and quarrying agriculture, forestry and fisheries, and transport and communications sectors remained at the previous year's level (Table 22).

VI. FIXED ASSETS (AT BOOK VALUE)

The aggregate values of fixed assets (at book value) of enterprises covered in this survey are presented in Table 23, while Table 24-29 show

the breakdown on regional basis.

(a) **Total Fixed Assets (At Book Value)**

In 1999, the book value of fixed assets held by foreign firms operating in Nigeria rose from N220,295.3 million in 1998 to N249153.3 million, representing an increase of 13.0 per cent over the preceding year's level. The book value of machinery and equipment remained the largest component of fixed assets, accounting for 37.0 per cent of the total, while other unspecified assets, furniture and fixtures, real estate and motor vehicles accounted for 2.11, 20.3, 16.5, 5.1, per cent, respectively. Analysis by sectors revealed that mining and quarrying registered the largest share (N154,873.8 million), followed by manufacturing and processing (N46,955.8 million) and transport and communications (N25,717.9 million) Table 23.

(b) **Fixed Assets (At Book Value) by Companies of U.K. Origin**

The book value of fixed assets belonging to companies of British origin decreased by 1.2 per cent to N50,165.5 million (Table 24). However, the book values of furniture and fixtures, and other unspecified assets increased, while the other components of fixed assets recorded declines during the review period. The book values of furniture and fixtures rose from N8,275.2 million in 1998 to N8,544.9 million, while that of other unspecified assets increased by 4.2 per cent to N5,218.1 million. The analysis further revealed that the bulk of fixed assets of the UK companies was in manufacturing and processing sector valued at N32,720.6 million, representing 65.2 per cent of the total. The transport and communications and trading and business services sectors accounted

for 27.8 and 6.5 per cent of the total, respectively. However, the book value of the fixed assets of mining and quarrying fell below the preceding year's level, while miscellaneous economic activities sector recorded negative value of N752.3 million, indicating the use of obsolete assets.

(c) **Fixed Assets (At Book Value) by Companies of U.S.**

Fixed assets at book value by companies of U.S. origin amounted to N70,925.5 million, the same figure reported in 1998 (Table 25). This was attributed to the components of the book value of assets which remained at the preceding year's level. However, the survey revealed that fixed assets in mining and quarrying sector accounted for 74.1 per cent of the aggregate book value of fixed assets owned by companies of U.S. origin.

(d) **Fixed Assets (At Book Value) by Companies of Western Europe Origin (Excluding the UK)**

The book value of fixed assets of companies from Western Europe (excluding the U.K.) fell by 2.0 per cent to N97,305.8 million. The companies engaged in miscellaneous economic activities sector accounted largely for the decline. The negative book value of fixed assets worth N951.9 million, registered in 1998 rose further to N3,292.0 million in the review period. The book value of assets in the trading and business services sector also fell from N1,547.7 million in the previous year to N1,133.9 million. However, the mining and quarrying, manufacturing and processing; agriculture, forestry and fisheries; transport and communication; and building

and construction sectors' fixed assets at book value increased slightly. The book values of real estate, furniture and fixtures and other unspecified assets increased, while that of machinery and equipment and motor vehicles declined. "Other" fixed assets book value rose from N32,870.6 million in 1998 to N33,390.0 million, representing 34.0 per cent of the total fixed assets at book value in the region. The value of real estate, furniture and fixtures fixed assets accounted for 47.0 per cent of the total. (Table 26).

(e) **Fixed Assets At Book Value by Companies of Asian Origin**

Fixed assets, at book value by companies of Asian origin rose from N2758.6 million to N2,855.9 million in the period under review (Table 27). The activities of firms in the manufacturing and processing sub-sector accounted for the increase as the book value of fixed assets in other sectors remained at the previous years' level. The sub-sector's total share of the fixed assets, at book value in the region also increased.

(f) **Fixed Assets At Book Value by the Companies from (Unspecified) Countries/Region**

At N8,432.2 million, the book value of fixed assets of companies from other unspecified countries/region increased by 1.0 per cent over the level in 1998. Machinery and equipment, which accounted for 68.2 per cent of the total book value of fixed assets in the region increased marginally from N5,695.4 million to N5,708.2 million in 1999. The sectoral analysis showed that fixed assets in manufacturing and processing sub-sector increased from N4,381.5 million in 1998 to N4,382.0 million. The book value of assets in mining and quarrying, agriculture, forestry and fisheries sectors

remained at the previous years position, while that of trading and business sector rose from N1,252.2 in 1998 to N1,331.4 in the period under review.

VII. RESERVES FOR DEPRECIATION

Cumulative reserves for depreciation increased by 8.7 per cent to N96,402.9 million from N88,699.4 million in 1998. The increase was shared by all the components of fixed assets in the period under review. The ratios of cumulative reserves for depreciation to the value of fixed assets, at cost, increased from 30.2 per cent in 1998 to 32.3, indicating that less assets were being acquired by foreign companies at rates lower than which the existing ones were written off. A sectoral analysis revealed that, the cumulative depreciation in all the sectors increased. (Table 29).

(a) Current Reserves for Depreciation

The amount of current reserves for depreciation rose from N5,666.3 million in 1998 to N7,703.5 million in 1999. The increase was attributed to all the components of fixed assets. Sectoral analysis showed that the miscellaneous sub-sector recorded the largest reserves for depreciation of N3,745.2 million, followed by the manufacturing and processing sub-sector which recorded N3,093.4 million in 1999. However, the current reserves for depreciation in mining and quarrying declined relative to the preceding year's position. (Table 30).

(b) Current Depreciation as percentage of Fixed Assets at Cost

The position of current reserves for depreciation to the value (at cost) of fixed assets increased to 2.6 percent from 1.9 percent in

1998. Sectoral analysis showed that only agriculture, forestry and fisheries showed a negative position. A disaggregation by components of assets revealed that the proportions stood at 1.4, 5.6, 1.1, 2.2 and 0.6 per cent for real estate, machinery and equipment, furniture and fixtures, motor vehicles and unspecified fixed assets, respectively. (Table 31)

VIII OWNERSHIP STRUCTURE AND EQUITY

(a) Cumulative Share Capital

The survey revealed that the cumulative paid-up capital (excluding reserves or unremitted profits) in all foreign owned or joint venture companies operating in Nigeria increased from N64,126.3 million in 1998 to N64,719.3 in 1999, indicating an increase of 0.9 per cent over the preceding year's level. Common stock held locally and by overseas investors amounted to N64,684.6 and accounted for 99.95 per cent of the total share capital (Table 32).

Aggregate foreign share was valued at N19,672.2 million in 1999 as against N19,549.6 million in 1998, which represents 30.0 per cent of the total share capital during the period under review. The observed increase in foreign share capital was owing to capital injection into the sectors, except, as in the previous year to agriculture-forestry and fisheries and transport and communications for which capital remained the same as in previous year.

(b) Components of Changes in Foreign Share Capital

Disaggregation of changes in foreign share capital revealed that expatriates equity increased to N913.9 million as against N703.0

million in 1998. (Table 33). Investment recorded through non-resident in preferred stocks increased from N17.3 million to N22.4 million.

IX. SUMMARY AND CONCLUSION

The net flow of foreign private investment in Nigeria in 1999 was N1,779.1, a substantial decrease from its N24,078.9 million position in 1998. The substantial decrease was attributed to net flow of companies of U.K. origin which declined from N14,140.4 million to N1,235.6 million during the period under review. Total investments of companies in all the regions decreased substantially. The survey revealed that the level of cumulative foreign private investment in 1999 was N154,188.6 million as against N152,409.6 million, which showed an increase of only 1.2 per cent. The increase was reflected in the contribution of companies from all the regions except the US. The activities of foreign investors in the manufacturing and processing, trading and business services increased to 23.3 and 7.0 per cent from 22.6 and 6.9 per cent respectively in 1999. The shares of mining and quarrying sector and miscellaneous fell to 38.8 and 27.0 per cent from 39.3 and 27.4 per cent in 1998.

The level of cumulative foreign investment in the manufacturing, and processing sector as disaggregated into 28 industrial groups increased by 6.7 per cent to N36,896.9 million in 1999, indicating a net investment of N2,309.4. The rise was accounted for by increase in the level of both paid-up capital plus reserves and other liabilities. The increase in aggregate investment in this sector was accounted for by 13 of the industrial groupings. Cumulative investment levels in nine groups remained static, while it declined in four groups.

The survey showed that aggregate net fixed assets worth N3,321.5 million was added to the existing stock of foreign owned companies in Nigeria in 1999. However, fixed assets worth N543.0 million were retired during the year, leaving a net accretion to stock of N4,778.5 million. Cumulative reserves for depreciation increased by 8.7 per cent to N96,402.9 million.

On ownership structures, the exercise revealed that, the cumulative paid-up capital (excluding reserves) in all foreign owned companies operating in Nigeria increased from N64,126.3 million in 1998 to N64,719.3 million in 1999, indicating an increase of 0.9 percent. Aggregate foreign share was valued at N19,549.6 million in 1998, which represented 30.0 per cent of the total share capital during the period under review.
